Please share with commissioners that were on the briefing today with Governor Noem.

Thank you for joining the Governor's County briefing today. Hopefully it was worth your time. There were approximately 65-70 participants. Governor Noem was gracious enough to extend her time past the allotted 30 minutes to answer questions.

A short list of topics covered:

1. Property Tax payment delay – not considering at this point
2. Upcoming Primary election – working on a plan with the Legislature, hope to distribute information soon.
3. Open Meeting requirements – will be sending electronic meeting protocol
4. Addressed courtroom policies – will be reaching out to Chief Justice Gilbertson to confirm policies for judge protocol.
5. TC Energy and the start of man camps – Governor's office has been in contact with TC Energy and they are aware of the state policies put in place. Will keep counties informed.
6. COVID-19 will be an on-going epidemic. She asked that everyone be patient.
7. Highest rate of unemployment requests are happening.
8. Currently (3/26/2020) 46 cases with 16 recoveries. Of those, 2-3 have been hospitalized, 1 deceased.
