Rob Mattox recently completed the most recent Lawrence County 911 Atlas.

This project was funded by the Bureau of Land Management (\$5,460.00) and was completed using Lawrence County GIS information. Rob emailed the completed information to the LC EM for county use. Copies of this information will be distributed by email to LC First Responder agencies such as Fire Departments, Law Enforcement Agencies, Ambulance Services, as well as LC Departments and other requesting government agencies.

I am proposing that the LC Commission give Rob Mattox permission to print and charge outside agencies and private individuals for copies of this atlas. This would eliminate Lawrence County from having to print the atlas and charge for them as was done in the past. Rob is fine with doing that but has requested permission to do that because the data is owned by Lawrence County.

Rob will set his own fees for printed books or a flash drive with the info or an email with the information. Examples of those who have requested these books in the past are delivery companies such a Fed-X, UPS, Speed-E along with numerous real estate companies, construction contractors and interested tourist venues.

Having Rob print the Atlas books for private agencies would be a good thing for us.
